## **Transportation Improvement Program (TIP) and 2024 Unified Planning Work Program (UPWP) - Development Schedule**

- **January 10**– Send Letter to Chief Elected Officials and PVPC Commissioners informing them of the start of TIP development for FFY2024 – FFY 2028. Letter will request an update to JTC membership by **January 27, 2023**, staff will perform additional outreach to municipalities that do not reply.
- **January 11** – Discuss TIP/UPWP development schedule with JTC
- **January 11** – Initiated Transportation Evaluation Criteria (TEC) Review by Project Proponents
- **January 24** – Project Universe introduced to MPO
- **January** – MassDOT distributes 2024-2028 financial information (Target funds)
- **February 1** - the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) will hold an onsite review as part of the Federal review process.
- **February 7/8** - MassDOT “TIP Days”, PVPC will meet with all MassDOT sections to review projects that may be funded in the next TIP cycle
- **February 8** – Updated TEC forms due to PVPC by end of business
- **February 9 (2<sup>nd</sup> Thursday)** – TIP sub-committee meeting scheduled to review updated TEC Forms
- **February 15 (3<sup>rd</sup> Wednesday)** – JTC will meet to begins Discussion of TIP based on new TEC rankings-Discuss Financials
- **February 28** – MPO reviews project list and provides feedback
- **February 28** –the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) will hold on Public Hearing on the PVMPO Federal Certification Review
- **March 8** – JTC Reviews MPO comments and identify a preferred list of projects
- **March 28**– MPO Reviews JTC recommendation of preferred list of projects and provides feedback

- **April 12** – JTC performs final review of TIP based on MassDOT project updated and MPO comments. JTC makes recommendation to MPO for their review and release of the Draft 2024-2028 TIP. JTC will make recommendation to the MPO to release the Draft 2024 UPWP.
- **April 25** – MPO reviews JTC recommended draft 2024-2028 TIP and Draft 2024 UPWP, make final project determination, releases TIP and UPWP for 21-day public review period
- **April 26 through May 16** – TIP and UPWP are out for public review and comment
- **May 10** – JTC reviews and comments on draft TIP currently out for public review – TIP Public Hearing
- **May 23** – MPO meets and reviews TIP and UPWP comments before making final endorsement of the 2024-2028 TIP and 2024 UPWP
- **May 24, 2023** – MassDOT Project Review Committee (PRC) meeting
- **May / June** – MPO to release the FFY 2024 Regional Transportation Plan (RTP) for public review and comment.
- **June / July** – MPO endorsed the FFY 2024 RTP
